Sub: "Essentiality Certificate"- Regarding opening of Medical College

Sir,

The desired certificate is as follows:

1. No. of institutions already existing in the State: 33 (6 Govt. +1RUHS+17RajMES+9Private)
2. No. of seats available in the MBBS Course in State: 5380 (1650 Govt.,2080 RajMES+1650 Pvt.)
3. No. of Doctors registered with the State Medical Council 64185
4. No. of Doctors in Government Service: 14145+2637(ME)
5. No. of posts vacant and these in rural/difficult areas 1760/556
6. No. of Doctors registered with Employment Exchange NA
7. Doctor population ratio in State 1:1230
8. The establishment of college would help resolve the problem of deficiencies and improve the availability of such medical manpower in State: The number of trained and qualified Doctor will increase to take care of shortage. More State students will be available to serve the State as per State policy for domicile.
9. The restriction imposed by the State Government, if any on students who are not domiciled in the State from obtaining admission in the State be specified. Restriction as per guidelines for admission by MCI/NMC, RUHS, State Government & court orders.
10. Full justification for opening of the proposed Medical College: We need more State-run medical colleges to give chances to meritorious and socio-economically backward state students and achieve better doctor population ratio.
11. Doctor population ratio proposed to be achieved 1:1000

The Rajasthan Vikas Sansthan, Jodhpur has applied for establishment of **Vyas Medical College at Jodhpur**. On careful consideration of proposal, Government of Rajasthan has decided to issue an Essentiality Certificate to the applicant for establishment of Vyas Medical College Jodhpur with 150 seats.

It is certified that:

- a) The applicant owns and manages a functional 605 bedded hospital.
- b) It is desirable to establish a Medical College in the public interest.
- c) Establishment of **Vyas Medical College, Jodhpur** by Rajasthan Vikas Sansthan Jodhpur is feasible.
- d) Adequate clinical material as per the National Medical Commission norms is available.

- e) The Rajasthan Vikas Sansthan owns and possesses 18.58 Acres of land in Jhalmand village, Pali Road, Jodhpur on which non-agricultural use of land is permitted and a Medical College/Hospital can be established on it
- f) The building plan of the Hospital and Medical College has been approved by the competent authority, namely, Jodhpur Development Authority Jodhpur designated by the State Government for such purposes on 28-05-2020 (Copy of the approval is enclosed). However, *"The College Building is under process of construction (Ground and First Floor Stone work is done only) "as per inspection report. The Institution shall submit an undertaking that the building will be completed before the NMC inspection otherwise this Essentiality Certificate shall stand cancelled.*
- g) The Hospital and Medical College have been granted Completion Certificate/Building Use Certificate by the competent authority, Jodhpur Development Authority, Jodhpur designated by the State Government for such purposes (copy of certificate is enclosed).
- h) Essentiality Certificate for 150 seats has been considered and verified by taking into consideration the ratio of 100 MBBS seats for 10 lakh population as prescribed under National Medical Commission (Minimum Standard Requirements) for establishment of New Medical College/increase of seats in MBBS Course) Guidelines, 2023 notified by National Medical Commission, New Delhi.

It is further certified that in case the applicant fails to create infrastructure for the Medical College as per NMC norms and fresh admissions are stopped by the Central Government/NMC, the State Government shall take over the responsibility of the students already admitted in the College with the permission of the Central Government/NMC.
